Why Vibrant CSO/ NGO Sector is needed in Bangladesh



CHIEF GUEST: Dr Qazi Kholiquzzaman Ahmad

An economist and development thinker and practitioner, **Dr Qazi Kholiquzzaman Ahmad** is currently Chairman of Governing Council of Dhaka School of Economics (DScE), which is, a constituent institution of the University of Dhaka

and is devoted to both post-graduate and undergraduate studies in economics and related subjects; and Chairman, Palli Karma-Sahayak Foundation (PKSF), which is, under his leadership, promoting human-centric, multidimensional, integrated approaches to enable the downtrodden of Bangladesh touched, to move out of poverty and on to sustainable development pathways. He has been awarded with the Independence Award 2019, the highest Bangladesh National Civilian Award, presented by the Government of Bangladesh and he has been also Awarded Ekushey Padak 2009, one of the highest Bangladesh National Civilian Awards, presented by the Government of Bangladesh. Recently he has received the National Environment Award 2019, presented by the Government of Bangladesh.

Dr Qazi Kholiquzzaman Ahmad received MA (Economics) from the University of Dhaka and Ph.D (Economics) from the London School of Economics and Political Science (LSE), London University. He was born in the district of Sylhet in 1943.

A participant in the Bangladesh War of Liberation in 1971, he worked in the Planning Cell of the then Bangladesh Government-in-exile. He is the Coordinator of Bangladesh Climate Change Negotiating Team at UNFCCC since 2009. He was the elected President of Bangladesh Economic Association (BEA) for three consecutive terms from 2002-2010. In 2010. He was a Member of the UNFCCC Clean Development Mechanism (CDM) Executive Board (2009-2014); and was a Coordinating Lead Author of the Intergovernmental Panel on Climate Change (IPCC)-Third Assessment (completed in 2001) and a Lead Author for IPCC Fourth Assessment (2004-2007).

Dr. Ahmad has to his credit a wide range of research works and publications (including authored/co-authored/edited/co-edited 40 books and over 250 articles/research reports and papers), at home and abroad, including on policy planning, rural development, poverty alleviation, human development, technology, employment, gender issues, regional cooperation, water resources, environment, and climate change.

SPECIAL GUEST: Mia Seppo

Mia Seppo joined the United Nations Country Team in Bangladesh as the Resident Coordinator and UNDP Resident Representative in October 2017. Subsequent to the adoption of the UNGA Resolution 72/279, Ms. Seppo, with effect from 1 January 2019, has been designated as the UN Resident Coordinator of the United Nations system's operational activities for development in the People's Republic of Bangladesh.

Prior to her appointment in Bangladesh, Ms. Seppo has served as the UN Resident Coordinator and UNDP Resident Representative in Malawi from April 2013 to October 2017, where among other initiatives she coordinated the UN system and partner support to the tripartite elections held in May 2014, the devastating floods in 2015 and the humanitarian response to the food insecurity in 2016-2017. Between 2010 and 2013, she served as the UNDP Country Director in Sierra Leone, leading the UN support to the tripartite elections held in 2012. Ms. Seppo contributed to the UN's work on aid coordination and development effectiveness in both countries. In partnership with the Peace Building Mission, Ms. Seppo led UNDP's work on conflict prevention in Sierra Leone and the establishment of a National Peace Architecture in Malawi.

Ms. Seppo served in the Regional Bureau for Africa in New York from 2005 to 2010, covering a portfolio of crisis countries, in particular the Democratic Republic of Congo and Burundi. Earlier,



Ms. Seppo started her UN career in 1996 with a focus on governance and human rights issues. Prior to her joining the UN, Ms. Seppo worked for civil society and think tanks, including the Finnish Committee for European Security.


Ms. Seppo is a Finnish national and holds a Master's Degree in Social Sciences from the University of Helsinki, Finland.

CHIEF GUEST: Saheen Anam



Shaheen Anam is the Executive Director of Manusher Jonno Foundation (MJF), a grant making organization supporting Human Rights and Governance work of organizations(approx 250) in Bangladesh.

She has worked for CARE Bangladesh as the Coordinator for their largest program and for the Ministry of Women's Affairs as Project Director for a Gender Equality Project. She has also worked in International Organizations such as UNDP and UNHCR both in Bangladesh

and Abroad. Shaheen Anam has a Masters in Social Work from the Hunter College School of Social Work, New York and Masters in Psychology from Dhaka University. She facilitated the process that raised the demand for enactment of the Right to Information (RTI) Act in Bangladesh and is now promoting implementation of law as the Convener of RTI Forum. She is at present involved with a number of policy advocacy and law reforms/formulations.

Shaheen Anam is committed to upholding the rights of the most marginalized people. She is known as a human rights and women activist. She is closely linked to the women's movement and is associated with national, regional and international coalitions/ networks promoting women's rights. She contributes articles in national dailies and is regularly invited to speak in Bangladesh and abroad.

Pierre Hauselmann is Swiss francophone. He is the first Executive Director of the Humanitarian Quality Assurance Initiative. Pierre holds a MSc. in environmental management from the London University, with a focus on NGO management and auditing. Before being at HQAI, he was Head of Verification at HAP International and then at CHS Alliance. He moderated the writing group that developed the final version of the CHS. Pierre has 25 years of experience in ethical standard development, certification and verification. He is a founding member of the Forest Stewardship Council (FSC) and collaborated with a number of schemes in the sustainable development sector,

including Fairtrade and Social Accountability International. He participated as technical expert in the development of several ISO standards on environmental management in representation of the World Wide Fund for Nature (WWF) International.

Monjurul Ahsan Bulbul is currently working as the CEO of Ekushey Television (ETV) . he has obtained his MA [Master of Arts] and LLB [Graduation in Law] from Dhaka University. Diploma in Journalism from International Institute of Journalism, Berlin, Germany.

He participated advance course on journalism and democracy in FOJO- University of Kalmar, Sweden, and different courses on journalism and broadcasting run by the Commonwealth Press Union-CPU, Commonwealth Broadcasting Association-CBA, Thomson Foundation, UK, APTN/UK-Hong Kong, Press Institute of Bangladesh-PIB, National Institute for Mass Communication-NIMCO.

Monjurul Ahsan Bulbul was chosen as the Chairman of the jury board of UNESCO/ Guillermo Cano World Press Freedom Prize for 2013. This is the highest media related award in the Globe. Previously He served as member of Jury board for three years. His previous professional experiences include working for the country's oldest newspaper - the Daily Sangbad, the Daily Jugantor, ATN Bangla Television, and Boishakhi Television. Over his more than three decades practical experience in print and electronic media journalism, Bulbul has earned a number of awards and honors home and abroad. He also served as the elected president of the Bangladesh Federal Union of Journalists (BFUJ).

Monjurul Ahsan Bulbul began working for The Daily Sangbad, the oldest and most respected daily in Bangladesh, in 1987. From 1987-2000, he worked as sub-editor, National desk editor and news editor. In 2000, he left The Daily Sangbad to start a news daily Jugantor, now the country's one of the largest-circulation Newspaper, where he was its Founder News Editor.

Anne Street has worked on humanitarian policy issues since 2005, most recently as Head of Human-itarian Policy at CAFOD (Caritas England and Wales). Her work has focused on humanitarian system change, humanitarian financing and conflict and peace-building. In 2015, in the run-up to the World Humanitarian Summit, she was one of 4 co-founders of the Charter for Change, an initiative which has become a key vehicle for organisational change amongst its 35 INGO signatories as well as an advocacy tool to promote improved international humanitarian actors partnerships with na-tional actors, encouraged by the 135 national NGO endorsers of the Charter.

She is a passionate advocate of the localisation agenda. Prior to focusing on humanitarian policy she worked on development and humanitarian pro-grammes, with a geographical focus on Latin America and the Caribbean. She holds a bachelor's degree in politics and sociology and a Masters degree from the London School of Hygiene and Tropical Medicine.

practitioners. Mr. Sarker is also the Secretary of the National Alliance of Humanitarian Actors, Bangladesh (NAHAB). He has been the chairman of Society for Social Services (SSS). With his dynamic leadership, POPI has been awarded several prestigious awards including Citi Micro Entrepreneurship Award - 2016.





Gawher Nayeem Wahra has a long experience of working with grass root organizations who are managing humanitarian and Development Programme. He is the founder convener and is currently acting as the member secretary of Foundation for Disaster Forum (DF) which is a national membership organisation of 76 agencies and individuals working in the field of humanitarian response in Bangladesh. He is also the founder member of South Asian Disaster Network "Duryog Nivaran" He has over 30 years experience in the field of managing

complex emergencies and natural disasters at local, regional, national and international level. He worked with Oxfam, CARE, ActionAid, Save the Children, PLAN, Swiss Development Cooperation, UNICEF and BRAC. In 2011, Mr Wahra was elected as Independent Member of Certification and Review Board (CARB) of Humanitarian Accountability Partnership (HAP; a Geneva based humanitarian organisation) followed by which he became the chair of the board. Facilitate local CSO/ NGOs to grow as sovereign and sustainable sector

CHIEF GUEST: Nick Guttann



Nick Guttmann has worked in the humanitarian sector for over 30 years and has significant expe-rience at field, HQ and alliance levels. Nick is currently Head of the Humanitarian Division at Christian Aid and is on the board of the CHSA and has represented Christian Aid on the Participation workstream of the Grand Bargain. Nick was one of the founders of the START Network and was its chair for several years. He has previously served on Board and Executive Committee of the ACT Alli-ance.

Since 2001 Nick has been head of the Humanitarian Division and developed and led Christian Aid's partnership based emergency response now seen as one of the lead-ing exponents of

locally led emergency response. This has included major responses in Nigeria, the DRC, Bangladesh, India, Philippines, Ethiopia, South Sudan, Nepal Haiti and most recently Malawi and Zimbabwe following cyclone Idai. Nick started his career in International Development in Ethiopia in 1988 working for Concern Worldwide. He worked for Concern for 13 years including playing a leading role in Concern's emergency responses in Iran and Iraq after the 1st Gulf war, Somalia on 2 occasions, Rwanda, Burundi and Zaire from 1994 – 1997, Sierra Leone, Liberia, South Sudan, Mozambique, Bangladesh, Kosovo and Albania.

wHe specialized in logistics and commodity distributions with the systems he developed being key reference documents for the first SPHERE Handbook. He is passionate about accountability to affected communities and has always tried to make it central to the work of the agencies he has worked for.

Prior to entering international development Nick was a community worker in South London. He studied at South Bank Polytechnic and completed a masters' degree in Development Studies at SOAS in 2000.

CHIEF GUEST: Shireen Huq



Shireen Huq is a renowned activist in Bangladesh. The organization she helped found, Naripokkho, began in 1983, just 12 years after Bangladesh won its own independence. It has become a leading voice of women's rights in the country. At the time she started Naripokkho, Shireen was pursuing a PhD in the UK. She was pulled from academia to activism by an explosion of interest in feminism in the context of a new country where women's rights were sidelined in political discussions. When women gathered to talk, Shireen recalls, "We had no idea of the intensity of the sense of injustice that lay beneath the surface, ready to explode." From 1987 to 2006, Shireen served as an advisor to the Danish development agency,

DANIDA, but her work for Naripokkho - all of it voluntary and uncompensated - has always been her true calling.

SPECIAL GUEST: Jeremy Wellard

Jeremy is Regional Representative for Asia and the Pacific for ICVA, a global network that provides policy, advocacy and operational support to national and international NGOs and NGO Networks working in the humanitarian settings across the region. He also heads ICVA's global work on localization and its impacts on NGO action. Previously he was regional focal point for the World Humanitarian Summit and the preceding regional and global consultations, working for UNOCHA's Regional Office for Asia and the Pacific. Jeremy has worked in wide-ranging roles for government and non-government organizations and in the private sector. He is a student of the Behavioural Sciences and holds a Master's Degree in International Development studies.

Anita Kattakuzhy is a humanitarian campaigner, currently based in Jordan, working with Oxfam over the past 8.5 years with a special focus on localization policy and advocacy in the past 3 years. Aroma Dutta is a Bangladeshi social and human rights activist. In February 2019, she was nominated by the ruling party, Bangladesh Awami League, to a seat reserved for women in the 11th parliament of Jatiya Sangsad. Dutta's grandfather. Dhirendranath Datta, a member of the National Assembly of Pakistan and the first person to demand Bengali be made a state language in Pakistan. He was killed in the Bandladesh Liberation war by members of the Pakistan army and is considered a martyr in Bangladesh. Her uncle was the filmmaker Ritwik Kumar Ghatak. Aroma's father. Saniib Datta, was a journalist who worked in the Pakistan Observer. Dutta is an executive director of PRIP (Private Rural

Initiatives Program) Trust. She served in the National Human Rights Commission of Bangladesh. n 2016, Dutta was awarded the Begum Rokeya Padak by the Government of Bangladesh She has called for security forces to be deployed in vulnerable election areas for elections to take place. In May 2017, she received the Danbir Ranada Prasad Memorial Honour and Gold Medal by the Kumudini Welfare Trust of Bengal.

Mohsin Ali. the Founder of WAVE Foundation is serving the organization as an Executive Director since 1990. Takeaways, common minimum position, unity course of action and way forward

CHIEF GUEST: Dr. Atiur Rahman



Dr. Atiur Rahman is a Professor (Honorary) of Department of Development Studies, University of Dhaka. Dr. Rahman served as the Governor of the Central Bank of Bangladesh during May 2009- March 2016. He occupied different positions in eminent research and academic institutions in addition to currently chairing the Board of Directors of Unnayan Shamannay.
