To <b>discuss current issues in international level / Inter Agency Standing Committee (IASC)</b> in respect of Grand Bargain (GB), Charter 4 Change (C4C), Principle of Partnership (PoP) agreements, IASC interim guidance on localization, duty care and flexibility etc. and its implications in Bangladesh.</li> <li>2. To <b>re-energize local activists</b> in view of four principles of our 1971 liberation war (<b>Democracy, Socialism, Secularism and Nationalism</b>), <b>thereby promoting humanitarianism and development nexus.</b></li> <li>3. To <b>discuss the effects of COVID 19 pandemic in aid sector</b>, the future trend of NGOs/CSOs and which <b>reaffirm the need for independent and sovereign local NGO/CSO sector in Bangladesh, emphasizing local/own resource mobilization.</b></li> <li>4.
